

STUDENT USE OF CARS AND STUDENT PARKING

Driving and parking a vehicle at John Glenn High School is a privilege, and will be limited by the number of available student parking places. Only seniors and juniors will be permitted to purchase a student parking permit. Sophomores will be permitted to purchase a parking permit second semester. All others will be considered on extenuating circumstances and the approval of the building administrator. Students are responsible for understanding and abiding by the following guidelines and rules:

The following Student Driver Guidelines will be enforced for student parking:

1. You must obtain a JGHS Student Parking Sticker to park on campus. Applications are available during registration or in the main office. The completed form must be signed by the student and parent/guardian and submitted with cash or a check for \$25.00. A vehicle registration and valid driver's license must be presented at the time of application. If approved, a parking sticker will be issued. If you change vehicles during the school year you must turn in your original Parking Permit in order to receive a new Permit *free of charge*.
2. The sticker must be permanently applied to the rear window, on the passenger side of the vehicle that has been registered on the application form. If application to the rear window is not possible, sticker should be applied to the front passenger side windshield. (Permission must be given by administration if this is the case.)
3. Students may park only in those areas designated as student parking lots. Students may not park in lots designated as "Authorized School Personnel Only", "Faculty Parking" or "Visitor Parking". All John Glenn Students must park in the John Glenn student lots. No student is to drive a car to or from the Career/Tech program without a pass from the Career/Tech office. Further, students will park in spaces in the proper manner without blocking handicapped parking, crosswalks, fire lanes, etc.
4. Student vehicles may only be used for transportation to and from school. The closed campus policy prohibits students from entering the parking lots or leaving the premises during the school day without permission from the main office.
5. To help protect against theft and vandalism, no student is to be in any parking lot without permission from the main office. Remember to lock your car. The school assumes no responsibility for lost or stolen items or vehicles, nor any damage that may occur while parked at John Glenn. Driving and parking is at your own risk.
6. You must follow and observe all school rules, state and local ordinances, and have a properly licensed vehicle.

THE STUDENT MUST BRING WITH THEM THE ATTACHED APPLICATION, SIGNED BY A PARENT/GUARDIAN, THE VEHICLE REGISTRATION, A VALID DRIVER'S LICENSE AND \$25.00.

RULES REGARDING STUDENT DRIVING AND PARKING:

1. All vehicles parked on the school grounds must be registered with the school.

2. Registered vehicles must have the current parking sticker permanently applied to the rear window on the passenger side. If application to the rear window is not possible, sticker should be applied to the front passenger side windshield. (Permission must be given by administration if this is the case).
3. Parking is strictly limited to the student parking areas. Students may not park in lots designated as “Authorized School Personnel Only”, “Faculty Parking”, or “Visitor Parking”.
4. All student drivers must be licensed and covered by insurance. The school assumes no responsibility for lost or stolen items or vehicles, nor any damage that may occur while parked at John Glenn. Driving and parking is at your own risk.
5. There is to be no loitering in the parking lot or visitation of a parking lot without permission of the school
6. If in the opinion of school officials a student is driving in excess of 15 miles per hour or is driving in a careless, reckless or unsafe manner, driving privileges can be revoked and disciplinary action may result.
7. Student drivers who register to park on school property and who are given permission to do so are deemed to have consented to a search of their vehicles by school authorities, when building administrators reasonably suspect that drugs, alcohol, weapons, stolen property or other contraband may be present in their vehicles.
8. It is considered a privilege to park on school grounds. Parking regulations are strictly enforces. Students in violation of these rules are subject to discipline suspension, loss of driving privileges and/or vehicle ticketing/towing by the Westland Police. Warning notices may also be adhered to vehicles that are not displaying a JGHS parking permit.
9. Student drivers and passengers should wear seat belt. It’s the law
