Mr. Neal commented that he supports the administration's desire to demolish the building rather than maintain it, as elementary schools could utilize cost savings for improvements to those facilities.

Ms. May also indicated support for the demolition of the facility, and sharing the process for the decision.

Mr. Albrecht likewise indicated his support for demolition.

It was further discussed that the whole of the Board would be required to approve any and all contracts related to demolition of the facility at a time when that would be presented.
