I. Wayne Memorial Student Representatives – Junia Williams and Dinah Smith

II. Section 98c Learning Loss Grant – Nathan

Dr. Dignan introduced Ms. Adrienne Nathan, Director of Community Partnerships and Outreach. Ms. Nathan discussed the intent to apply for the Section 98c-Learning Loss grant. This grant is an extension of the Governor's and Federal Educational Emergency Relief funds, the district's current Continuity of Learning plan, and ESSER learning loss strategies. Upon approval, the district will receive an amount based on our per-pupil membership and will use the funds to implement evidence-based activities, assist educators in meeting the needs of all students, and provide assistance to families on ways to support students. All detailed plans and reports will be made available on the district website under our transparency reporting section.

III. Walker-Winter Update - Curry

Dr. Dignan introduced Ms. Jennifer Curry, Assistant Superintendent of Curriculum, Instruction, and Assessment. Ms. Curry offered an update on Walker-Winter. Two committees were formed to discuss the future of Walker-Winter. The Central Steering Committee was designed to steer the process and the Stakeholder Committee including staff and community members with the intent to make a recommendation to the board on December 12, 2022. The Stakeholders Committee will be recommending that the board vote to keep Walker-Winter open, dissolve the TAG Program, approve the bond updates, grade configurations, and boundaries.

I. Finance Committee Report - May

Ms. May shared the following comments from a prepared statement:

Ms. Brohl shared the need for the district to purchase headphones to support the implementation of the program Amira.

Mr. Wenzel informed the committee of the renewal and expansion of Informed K-12 licensing.

Mrs. Nathan shared with the committee information regarding the Student Spaceflight Experiments Program also known as SSEP. Our district is the only district in Michigan and one of 40 districts across the country that has reserved a spot on the International Space Station.

Mr. Spisak and Mr. Underwood provided an update regarding the Student Health Clinic at John Glenn.

Mrs. Cleaves presented both the Investment Report and Monthly Check Register.

Mr. Dignan shared district highlights.

Mr. Buckalew inquired about the SRO grant as well as the safety and mental health grants. Ms. May thanked the staff for their hard work and shared excitement regarding the student health clinic.

174.23 SUPERINTENDENT'S REPORT/COMMENTS – Dignan

Dr. Dignan congratulated Mr. McBride, the pledge students and the Wayne Memorial High School student representatives.

Dr. Dignan read from a prepared statement:

I want to thank our staff, students and administrators for a great launch during the school year. Everyone is working hard. I also want to honor our administrators for National Principal Month.

We held our WW NFL Flag games at EMU Rynearson Stadium (The Factory) on Saturday. The turnout was incredible and more importantly, the kids had a blast. Thank you to everyone involved, especially the coaches, activity coordinators, teachers and elementary administrators.

We launched our WW Connections Newsletter. This newsletter will be sent out twice a month and include highlights across Wayne-Westland Community Schools.

The Wayne Memorial Yearbook will be receiving a Gallery of Excellence Award for the 2022 Yearbook. Congrats to Ms. Jennifer Crane and her Yearbook staff. We will honor them at the November Board Meeting.

Middle School Career Cluster Experience-Fall 2022 at the WDFCTC: We want to thank the CTC leadership team, staff and middle school staff for bringing this to fruition. Eighth-grade students from the middle schools in the district will spend

approximately 1.5 hours exploring the various career clusters offered at William D. Ford Career Technical Center. This event will allow students to see demonstrations and engage in short activities and gain clarity regarding the different types of careers that exist. We have to be intentional in exposing students to the Career Tech Center.

ECF Grant: We are excited to announce that Wayne-Westland Community School District was awarded a grant through the FCC's Emergency Connectivity Fund to address the device and connectivity shortcomings experienced by our students, we were awarded 3.3 million. This funding provides all K-4th grade students with an iPad and nearly 1,700 5th - 12th grade students in need with a Chromebook equipped with built-in cellular data capability. This will help us cut the digital divide as we will get 5,000 devices (LTE iPads/Laptops) with built-in Wi-Fi. The devices have been hitting buildings over the last few weeks.

WDFCTC - Cisco Net Academy: We launched the Cisco-Cybersecurity this fall at CTC. Our students will get both high school credit and industry certification; we will eventually build a middle college to the program. Cisco Net Academy, which all districts (CTC's) are using for their building blocks for coding and cybersecurity (students can get the certifications as they take the courses). People that get all the Cisco certifications can walk into jobs at 85k. A special thank you to Mr. Josh Rychlicki, Ms. JaCinda Sumara and Clydene Stangvik (Cisco's Midwest Networking Academy Manager) for bringing this opportunity to WWCS for our students.

- T. Buckalew thanked the pledge and high school students for their contributions to the board meeting. He commented on Ms. Nathans's presentation and expressed that there was no question that the pandemic and poverty have taken a toll on education and 98C will help to correct the issues. He mentioned that Ms. May, Ms. Hines, and himself attended the MASB Annual Leadership Conference and received all good feedback about the district. He had the opportunity to speak with three of Wayne RESA's trustees and attend classes about volunteerism and attracting and retaining teachers.
- K. May thanked all of the student participants. She was delighted to announce that she witnessed how well-behaved the John Glenn students who attended a field trip at Eastern Michigan University were and that the staff was completely engaged with the students. She mentioned that she was able to attend the MASB Annual Leadership Conference and highlighted a few things that she learned about ethical decision-making, 7 lenses, strategic planning (which the district is already doing), legal issues, changes in Title IX, and advocating for public schools.
- M. Hines thanked the students and congratulated Mr. McBride. She thanked all of the staff members at Wayne-Westland Community Schools. She was excited about the information she received at the MASB Annual Leadership Conference such as managing a construction project, high school and beyond and creating trust. She will be hosting a Steam literacy and virtual reality round table with Natasha Lee.
- J. Albrecht thanked Ms. Nathan and felt the board needed to hear about the 98c learning loss grant. He thanked the parents for coming and speaking up and welcomed Mr. McBride. He mentioned that he was happy to be able to attend the two high school homecoming tailgating events.
